

## **The Do312 x Curb Sweepstakes Official Rules**

**NO PURCHASE NECESSARY TO ENTER, PLAY OR CLAIM A PRIZE.**

**A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN TO ALL LEGAL RESIDENTS OF CHICAGO, IL.**

**ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTERIES RECEIVED.**

The Curb x Do312 Sweepstakes (the "Sweepstakes") is sponsored by Curb x Do312 ("Sponsor") and is administered by Curb ("Administrator").

- 1. PROMOTION PERIOD:** The Sweepstakes consists of an Instant Win Game and a Sweepstakes that shall take place during the Sweepstakes Period. The Sweepstakes Period starts on September 15<sup>th</sup>, 2014 at 12:00 P.M. Eastern Time ("ET") and ends on October 14<sup>th</sup>, 2014 at 11:59:59 P.M. ET ("Sweepstakes Period"). Administrator's clock is the official clock for this Sweepstakes.
- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal United States residents in the 50 United States and the District of Columbia who are 17 years of age or older at the time of entry. Employees of Sponsor, Administrator, and any company or entity providing any Prize to be awarded in connection with the Sweepstakes (each a "Prize Provider") and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively "Released Parties") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Sweepstakes. All federal, state and local laws and regulations apply. Void in Puerto Rico, the United States Possessions and Territories, and where prohibited or restricted by law.
- 3. HOW TO ENTER THE SWEEPSTAKES AND PLAY THE INSTANT WIN GAME:** During the Sweepstakes Period, an eligible Entrant must download the Curb application and enter one of the designated promotion codes to be automatically entered to win. There is no cost associated with a contest entry. For every ride completed within the Curb Chicago service area that an Entrant takes with the Curb app before the winner is announced, Entrant will receive one additional bonus entry. - 4. RANDOM SWEEPSTAKES DRAWINGS:** Each date specified, Administrator will randomly draw (1) potential winner(s) from among the eligible Entrants to receive the prizes listed below (each a "Prize"). Each Entrant selected is deemed a potential winner ("Potential Winners") pending confirmation and/or verification of the Entrant's eligibility and compliance with the Official Rules as determined by Sponsor.
- 6. SWEEPSTAKES PRIZE AND ODDS OF WINNING:**

- A total of 3 Prizes will be awarded consisting of: (each a “Prize”). The approximate retail value (“ARV”) for each Prize is listed next to such Prize below.
  1. A pair of tickets to Citizen Cope (\$133.28), \$50 gift card to the House of Blues, and \$100 in Curb Credits.
  2. A pair of tickets to Porter Robinson (\$75.92) and \$100 in Curb Credits.
  3. A pair of tickets to Matisyahu (\$82.98) and \$100 in Curb Credits.
- The total ARV of all Prizes is \$642.18.

**B. Odds of Winning:** The odds of winning a Prize depends on the total number of eligible entries received during the Sweepstakes Period.

**7. TOTAL ARV OF ALL PRIZES IN THIS PROMOTION IS \$642.18.**

**8. HOW TO CLAIM A SWEEPSTAKES PRIZE AND AN INSTANT PRIZE:** The potential Winner will be notified via telephone and/or via e-mail within ten (10) business days of the random drawing. The Potential Winner must reply to Administrator within the time period indicated after notification or Sponsor may select an alternative Sweepstakes Prize Winner. Before being declared a Winner, the Potential Winner will be required to execute and return an Affidavit of Eligibility/Liability & Publicity Release and a tax acknowledgment form, within ten (10) business days from the date it is postmarked as having been sent by the Sponsor or its representative, or the Sweepstakes Prize may (in Sponsor’s sole discretion) be forfeited.
