

The Curb LA St. Patrick's Day Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER, PLAY OR CLAIM A PRIZE.

A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN TO ALL LEGAL RESIDENTS OF THE CITY OF LOS ANGELES, CA

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ENTERIES RECEIVED.

The Curb LA St. Patrick's Day Sweepstakes (the "Sweepstakes") is sponsored by Curb ("Sponsor") and is administered by Curb ("Administrator").

- 1. PROMOTION PERIOD:** The Sweepstakes consists of an Instant Win Game and a Sweepstakes that shall take place during the Sweepstakes Period. The Sweepstakes Period starts on March 4th, 2015 at 5:00 P.M. Pacific Time ("PT") and ends on April 19th, 2015 at 12:00 P.M. PT ("Sweepstakes Period"). Administrator's clock is the official clock for this Sweepstakes.
- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal United States residents in the 50 United States and the District of Columbia who are 17 years of age or older at the time of entry and who have never used the Curb app prior to the start of the Sweepstakes Period. Employees of Sponsor, Administrator, and any company or entity providing any Prize to be awarded in connection with the Sweepstakes (each a "Prize Provider") and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively "Released Parties") and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Sweepstakes. All federal, state and local laws and regulations apply. Void in Puerto Rico, the United States Possessions and Territories, and where prohibited or restricted by law.
- 3. HOW TO ENTER THE SWEEPSTAKES AND PLAY THE INSTANT WIN GAME:** During the Sweepstakes Period, an eligible Entrant must download the Curb application and enter the designated promotion code to be automatically entered to win. There is no cost associated with a contest entry.
 - a. **Limit:** One (1) Entry per person/email address during the Sweepstakes Period. In the event more than one (1) Entry is received from any one person/email address during the Sweepstakes Period, that person/email address will be disqualified from the Sweepstakes.
- 4. RANDOM SWEEPSTAKES DRAWINGS:** On the date specified, Administrator will randomly draw one (1) potential winner(s) from among the eligible Entrants to receive the grand prize and two (2) runners up to receive the second and third prizes listed below ("Prize"). The Entrant(s) selected is deemed a potential winner ("Potential Winners") pending confirmation and/or verification of the Entrant's eligibility and compliance with the Official Rules as determined by Sponsor.
- 5. SWEEPSTAKES PRIZE AND ODDS OF WINNING:**

- A.** Total of three (3) Prizes will be awarded consisting of (“Prize”):
- a.** Grand Prize: \$50 in Curb Credits, Bose SoundLink Portable Bluetooth Speaker III (\$299.99) – ARV \$349.99
 - b.** Second Prize: 213 Nightlife Hop Package, including two (2) drink chips for nine (9) bars and two (2) memberships to Cana Rum Bar – ARV \$200.00
 - c.** Third Prize: \$25 in Curb Credits – ARV \$25.00
- B. Odds of Winning:** The odds of winning the Prize depends on the total number of eligible entries received during the Sweepstakes Period.

7. TOTAL APPROXIMATE RETAIL VALUE (“ARV”) OF ALL PRIZES IN THIS PROMOTION IS \$574.99.

8. HOW TO CLAIM A SWEEPSTAKES PRIZE AND AN INSTANT PRIZE: The potential Winner will be notified via e-mail within five (5) business days of the random drawing. The Potential Winner must reply to Administrator within the time period indicated after notification or Sponsor may select an alternative Sweepstakes Prize Winner. If a Potential Winner is found to be ineligible or not in compliance with these Official Rules, declines to accept the Prize, Sponsor is unable to contact the Potential Winner, or in the event that the Prize confirmation or Prize is returned undeliverable, the Prize will be forfeited, and in the Sponsor’s sole discretion, the forfeited Prize may be awarded to an alternate Potential Winner. If the Sponsor wishes to select an alternative Potential Winner, Sponsor will select this alternative Potential Winner at random from the pool of eligible Entrants. The Potential Winner may be required to furnish proof of identification and other proof of eligibility under these Official Rules.

The right to receive a Prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor who reserves the right to substitute prize of equal or greater value in case of unavailability of prize or force majeure. Federal, state and local taxes, if any, are the sole responsibility of each winner. No substitutions, cash equivalents or transfers of a Prize permitted by the Prize Winner. All other costs and expenses not expressly set forth herein shall be solely the Winner’s responsibility, including, any and all applicable federal, state and local taxes.

9. LIMITATION OF LIABILITY:

- Curb and the Released Parties are not responsible for illegible, lost, late, incomplete, stolen, misdirected, postage due, or undeliverable e-mail or postal mail; or for any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability, or garbled, corrupt or jumbled transmissions, service provider/Internet/web site/use net accessibility, availability, or traffic congestion, or any technical, mechanical, printing, or typographical or other error, or unauthorized human intervention, or the incorrect or inaccurate capture of registration information, or the failure to capture, or loss of, any such information.
- Curb and Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any web site users, tampering, hacking, or by any of the equipment or programming associated with or utilized in the Sweepstakes and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to any web site(s). Curb and Released Parties are not responsible for any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from

participating in the Sweepstakes and/or accepting a Prize. If, for any reason, an entry is confirmed to have been erroneously deleted, lost or otherwise destroyed, corrupted or for any other reason not accepted as an entry into the Sweepstakes, the Entrant's sole remedy is to submit another entry into the Sweepstakes. If, for any reason, the Sweepstakes is not capable of running as planned, Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes in a manner it deems fair and reasonable including the selection of winners from among eligible entries received prior to such cancellation, termination, modification or suspension.

- Curb and Released Parties shall not be responsible or liable for entries that are entered by other than human means (such as by an automated computer program or any non-human mechanism, entity, or device), in excess of the stated limit, or for entries that are late, forged, destroyed, lost, misplaced, stolen, misdirected, tampered with, incomplete, deleted, damaged, garbled, or otherwise not in compliance with the Official Rules, and all such entries will be disqualified. IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.

11. PRIVACY POLICY: Any personally identifiable information collected during an Entrant's participation in the Sweepstakes will be collected by Sponsor or its agent and used by Sponsor, its affiliates, agents and marketers for purposes of the proper administration and fulfillment of the Sweepstakes as described in these Official Rules and in accordance with Sponsor's Privacy Policy as stated at <https://www.gocurb.com/privacy> and any opt-ins an Entrant may have agreed to during the registration process.

12. PUBLICITY RIGHTS: By participating in the Sweepstakes and/or accepting a Prize, each Prize Winner agrees to allow Sponsor and/or Sponsor's designee the perpetual right to use his/her name, biographical information, photos and/or likeness, and statements for promotion, trade, commercial, advertising and publicity purposes, at any time or times, in all media now known or hereafter discovered including live television, world wide, including but not limited to on the World Wide Web and Internet, without notice, review or approval and without additional compensation except where prohibited by law.

13. GENERAL: If it is discovered that an Entrant has registered or attempted to register more than once using multiple e-mail addresses, telephone numbers or multiple identities, all of the Entrant's entries will be declared null and void and any prize an Entrant might have been entitled to will not be awarded. In the event of a dispute as to the identity of a winner based on an e-mail address, the winning entry will be declared made by the authorized account holder of the e-mail address

submitted at time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sponsor and Administrator reserve the right, to disqualify any individual found, in its sole opinion, to be tampering with the operation of the Sweepstakes; to be acting in violation of these Official Rules; or to be acting in an unsportsmanlike manner or with the intent to disrupt the normal operation of a Sweepstakes.
